Safety information

- 7. Only charge with the supplied USB cable.

- 9. Bluetooth wireless technology operates within a range of about 10 m (30 feet). The maximum communication distance may vary depending on the presence of obstacles (people, metal objects, walls, etc.) or the electromagnetic environment.


Blood oxygen can be subject to wide fluctuations in a short period of time. Its level depends on many factors. Do not smoke, drink caffeinated beverages or exercise within 30 minutes before measuring your blood oxygen.

Intended Use

This smart watch is intended for monitoring fitness-related metrics such as heart rate, blood pressure, distance walked or run, calorie consumption and quality of sleep. Data measured should not be used for any medical, ambulatory, or dietary reference.

Charging

Fully charge the device (can take up to 3 hours) before using for the first time. To charge your device, plug the charging cable into the power adapter or USB port on your computer.



When fully charged, press and hold the side button for 3 seconds to power on the watch.



Pairing

Open the App and set up your profile, go to the [Device], Click [Add a Device], choose SWC-392 on the scanning list.

Using the Touch Screen





Bluetooth call

After connecting the smart watch to the phone, you can use the watch to make and answer phone calls via Bluetooth. You can also view the call history on the watch. You need to keep the connection between the watch and the phone stable when using the Bluetooth call function.



Sleep

If you wear the Smart Watch in your sleep, it can provide the hours slept and quality of sleep stats on both the screen and the APP. NOTE: Sleep stats are reset to zero at 8:00 pm.



Steps

Smart Watch automatically tracks steps taken and shows the stats on the screen. NOTE: Your movement stats are reset to zero at midnight.



Training

Tap the training icon on the menu to start a new training session, there are 123 sport modes to choose from. The last training will be shown on the training page.



Notifications

The watch can sync incoming notifications from Twitter, Facebook, WhatsApp, Instagram etc.

5 latest messages can be stored. Note: You can switch the incoming notifications on/off in the APP.

Using in wet conditions

Your device is water-resistant, which means it is rainproof and splashproof and can stand up to even the sweatiest workout.

NOTE: Do not swim with your smart watch. We also don't recommend showering with your wristband; though the water won't damage the device, wearing it 24/7 does not give your skin a chance to breathe. Whenever you get your bracelet wet, dry it thoroughly before putting it back on.
